# City of Victoria L.I.F.E. 2014 (Leisure Involvement for Everyone)

## Intent

The L.I.F.E. program provides a combination of annual credit and 52 drop in visits to eligible low-income individuals and families to use towards recreational programs and services. The City and its Partners are committed to ensuring that all its residents have access and choices in their leisure opportunities. Recreation contributes to one's mental and physical health and stimulates the development of healthier and stronger individuals and families.

Bring your completed Application Form to the Crystal Pool and Fitness Centre, 2275 Quadra Street, Victoria. Applications are processed and acceptance letters should be received by mail/E-mail within approximately 10 working days.

## Eligibility Requirements

- **Only** City of Victoria **permanent residents** may apply for the Program. This includes all family members/Dependents residing at the same address. Applicants must have lived in the City of Victoria for the previous 30 days and be able to demonstrate residency within the City of Victoria.
- Post-Secondary Students are not eligible. This is inclusive of students on leave for less than 1 year.

## Guidelines:

- Credit amount for the 2014 program is: \$40 per preschooler (0-4 yrs.) \$40 per adult (18 yrs. & up) and \$60 per youth (5-17 yrs.) until December 31, 2014.
- Credit can be used towards drop-in punch cards, monthly passes, program registration fees or memberships.
- Credit cannot be used for single admissions or merchandise.
- The L.I.F.E. Card & Credit cannot be redeemed for cash, is non-transferable and expires on December 31 of 2014.
- If pass is lost or stolen, there is a \$5 replacement fee for a maximum of **one** card replacement per person per year.
- When the lost card is replaced 4 visits per month or number of scans, whichever is greater will be deducted.
- All applications for the L.I.F.E. program will be processed in confidence and on a first come first served basis.
- All information provided in the application remains confidential, unless required by a Freedom of Information request.
